

# Music Artist Management Contract



The Manager agrees to represent and manage the Artist in all matters relating to the Artist's career in the entertainment industry, including but not limited to securing contracts, negotiating deals, arranging performances, and providing career advice.

## Duration

- This Contract shall commence on the date first written above, and the Manager's services shall begin immediately.
- The commencement date marks the start of the initial term of this Contract, spanning a duration of two (2) years.
- Upon mutual agreement, this Contract may be renewed for additional one (1) year terms. Either party must provide written notice of intent to renew or terminate at least sixty (60) days prior to the end of the current term.

## Compensation

The Artist agrees to pay the Manager a commission of 20% of the Artist's gross earnings from all activities in the entertainment industry during the term of this contract. This commission shall be payable upon receipt of earnings by the Artist.

## Rights and Obligations

- Manager's Responsibilities

The Manager shall use reasonable efforts to promote and enhance the Artist's career. The Manager agrees to act in the best interests of the Artist and to perform their duties professionally.

- Artist's Responsibilities

The Artist agrees to cooperate fully with the Manager and to provide all necessary information and access required for the Manager to perform their duties effectively. The Artist shall not engage another manager for the same services during the term of this contract.

## Expenses

The Artist agrees to reimburse the Manager for reasonable expenses incurred in the performance of their duties under this Contract, provided such expenses are pre-approved by the Artist. These expenses may include travel, accommodations, promotional materials, and other related costs.

## Termination

- Termination for Cause

Either party may terminate this Contract with thirty (30) days written notice if the other party breaches any material term of this Contract and fails to cure such breach within fifteen (15) days of receiving notice of the breach.

- Termination Without Cause

Either party may terminate this Contract without cause by providing ninety (90) days written notice to the other party. Upon termination, the Manager shall be entitled to commissions on all earnings from contracts and agreements secured during the term of this contract.

## Confidentiality

Both parties agree to keep confidential all information disclosed during the term of this Contract, including business strategies, financial details, and other proprietary information. This confidentiality obligation remains in effect even after the termination of this contract.

## Indemnification
